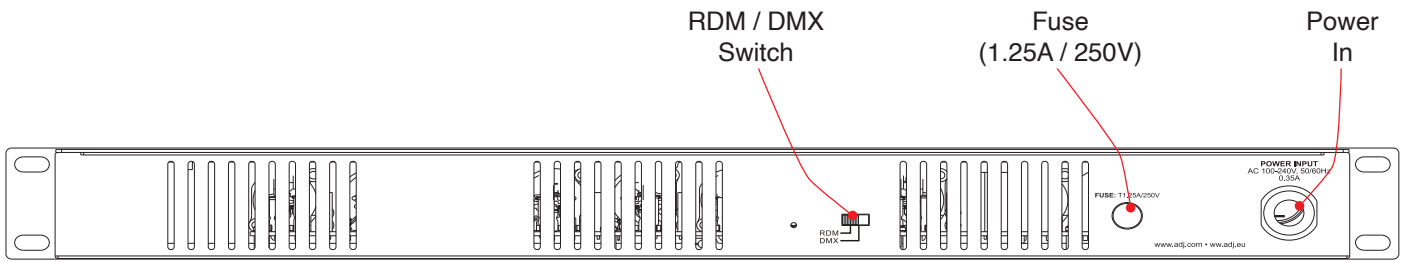
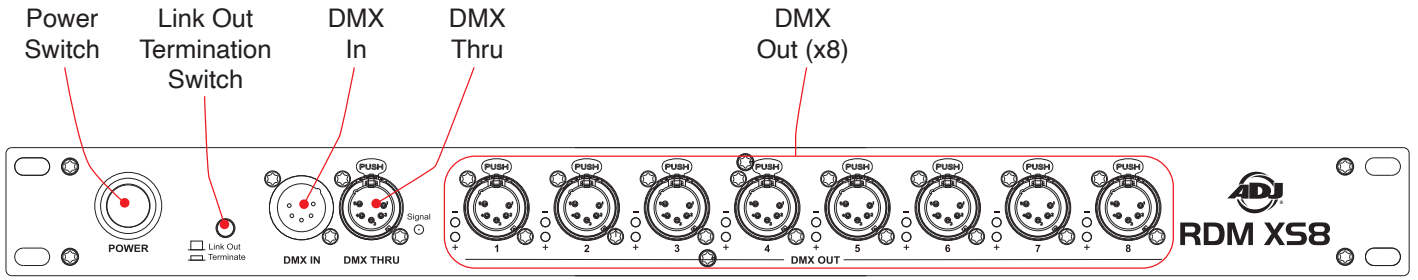

- Never block the ventilation holes. Always be sure to mount this device in an area that will allow proper ventilation. Allow about 6" (15cm) between this device and a wall.
- This unit is intended for indoor use only. Use of this product outdoors voids all warranties.

- Please route your power cord out of the way of foot traffic. Power cords should be routed so they are not likely to be walked on, or pinched by items placed upon or against them.

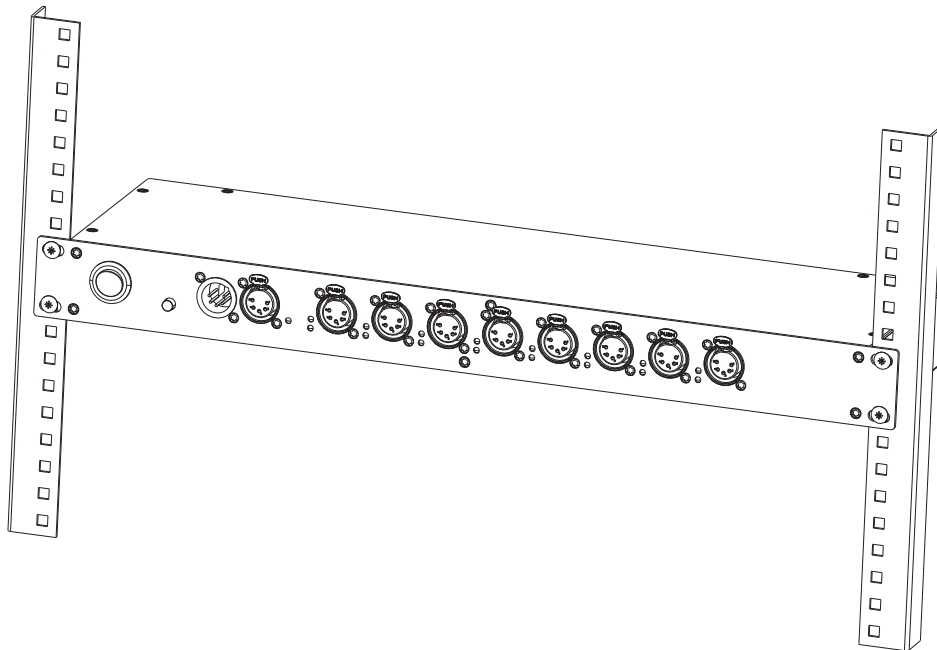
DO NOT INSTALL THE DEVICE IF YOU ARE NOT QUALIFIED TO DO SO!

Maximum ambient operating temperature is **113°F (45°C)**. Do not use this device when ambient temperature falls exceeds this value!

Device should be installed away from walking paths, seating areas, or areas where unauthorized personnel might reach the device by hand.

RACK MOUNTING

This device can be mounted in a standard 19-inch rack using the mounting brackets located on each side of the device. Make sure to use mounting hardware that fits the mounting holes on the device as well as the rack itself. Use all four (4) points on the mounting brackets to ensure that the device is mounted securely. Please see the illustration below for reference.



MULTIPLE DEVICES

Up to **32 devices** may be daisy-chained directly together and linked to a single controller. Do NOT exceed this maximum number of directly connected units. Please note that the Link Out / Termination Switch must be in the “Link Out” position in order to use this feature, except for the last unit in line, which must should have the switch set to the “Termination” position.

REMOTE DEVICE MANAGEMENT (RDM)

NOTE: *In order for RDM to work properly, RDM enabled equipment must be used throughout the entire system, including DMX data splitters and wireless systems.*

Remote Device Management (RDM) is a protocol that sits on top of the DMX512 data standard for lighting, and allows the DMX systems of the fixtures to be modified and monitored remotely. This protocol is ideal for instances in which a unit is installed in a location that is not easily accessible.

With RDM, the DMX512 system becomes bi-directional, allowing a compatible RDM enabled controller to send out a signal to devices on the wire, as well as allowing the fixture to respond (known as a GET command). The controller can then use its SET command to modify settings that would typically have to be changed or viewed directly via the unit's display screen, including the DMX Address, DMX Channel Mode, and Temperature Sensors.

Please be aware that **not all RDM devices support all RDM features**, and therefore it is important to check beforehand to ensure that the equipment that you are considering includes all of the features that you require.

OPERATION

DMX MODE

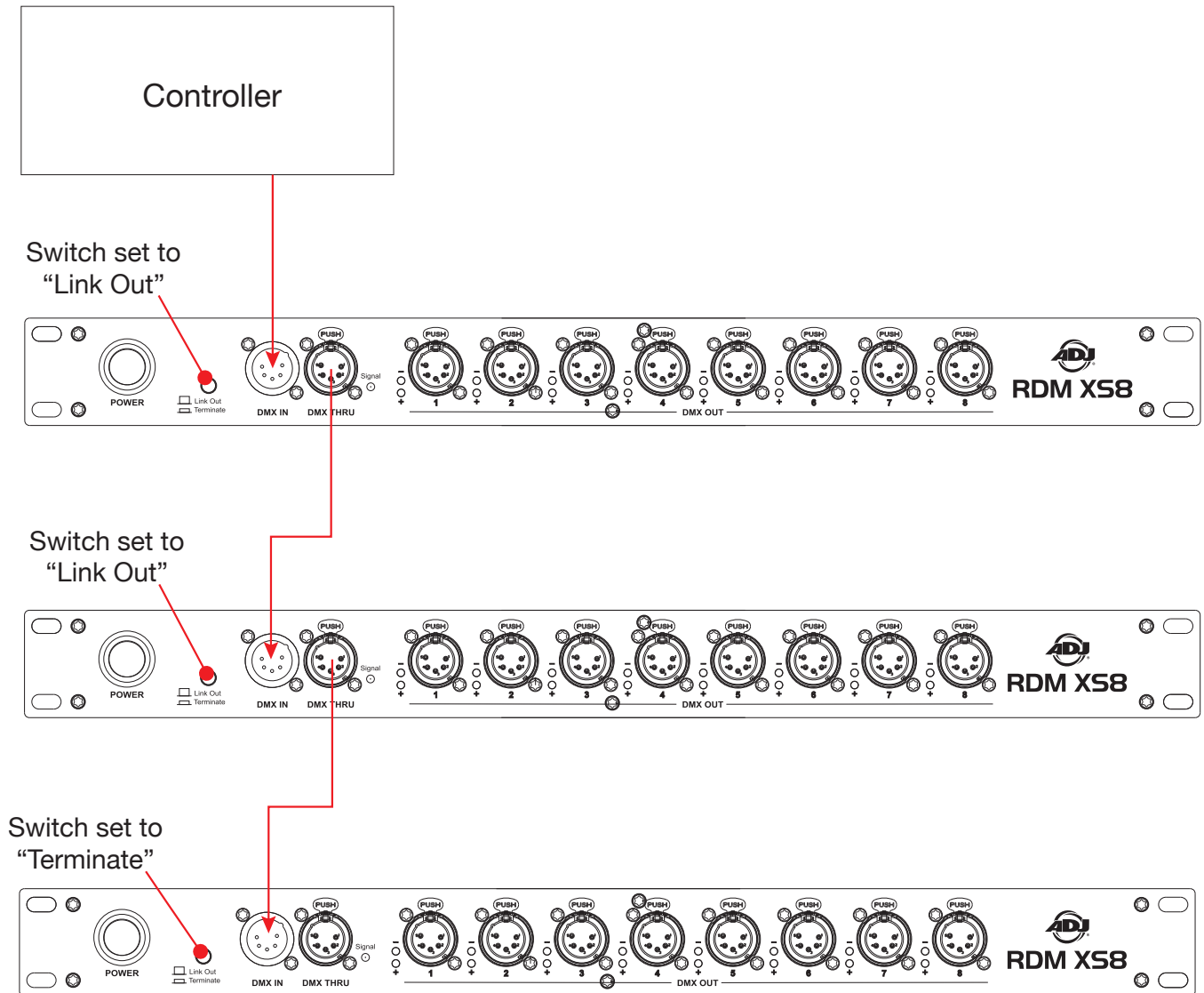
To activate this mode, move the RDM/DMX Switch to the “DMX” position. The RDM XS8 will then output the received DMX signal **WITHOUT RDM** to any devices connected to the six (6) DMX Output ports.

RDM MODE

To activate this mode, move the RDM/DMX Switch to the “RDM” position. The RDM XS8 will then output the received DMX signal **WITH RDM** to any devices connected to the six (6) DMX output ports.

LINK OUT / TERMINATION SWITCH

When this switch is in the “Link Out” position, the RDM XS8 will also pass signal through the “DMX Thru” port. This signal can be sent to additional RDM XS8 units by connecting the “DMX Thru” port of the first unit to the “DMX In” port of the next unit in line, as shown in the illustration below. Up to 32 units may be linked together in this way. The final unit in line should have the switch set to the “Terminate” position.



CLEANING AND MAINTENANCE

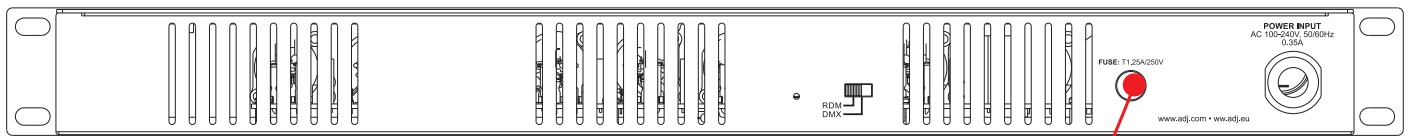
Due to fog residue, smoke, and dust cleaning the internal and external optical lenses must be carried out periodically to optimize light output.

- Use normal glass cleaner and a soft cloth to periodically wipe down the outside casing.
- Always be sure to dry all parts completely before plugging the unit back in.

Cleaning frequency depends on the environment in which the fixture operates (i.e. smoke, fog residue, dust, dew).

FUSE REPLACEMENT

This device features a replaceable fuse located alongside the power cord on the back side of the device, as shown in the illustration below. When changing the fuse, replace the fuse only with an identical **T1.25A / 250V** fuse.

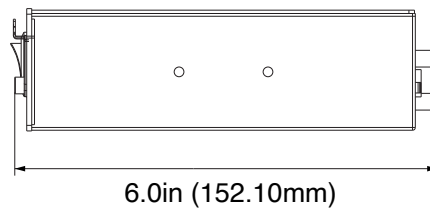
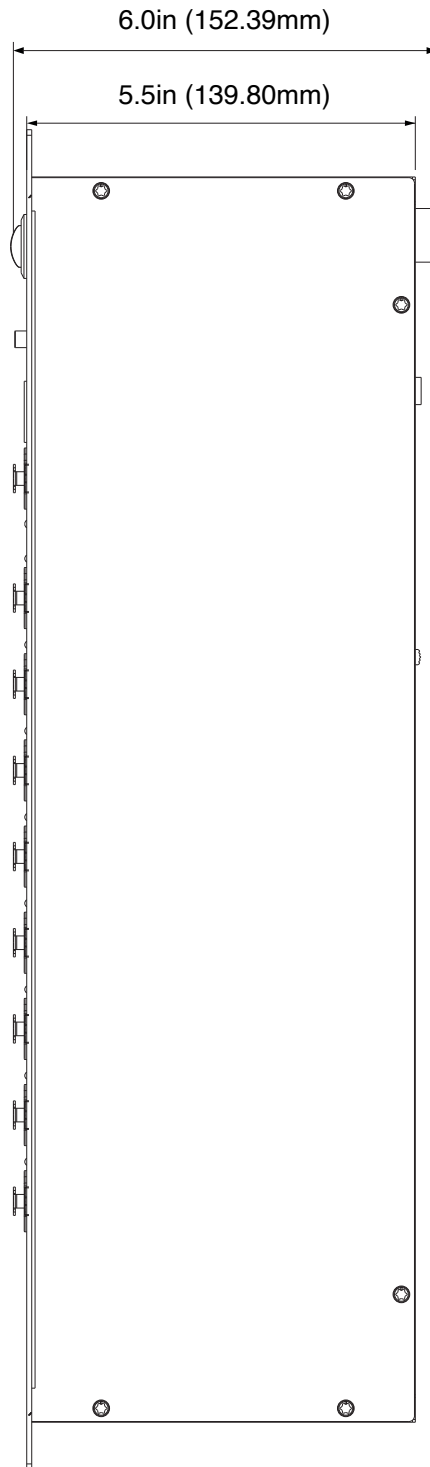
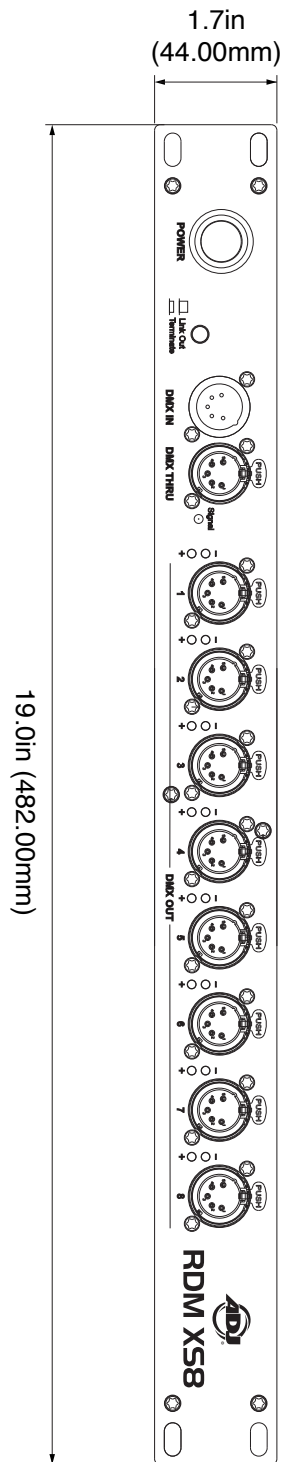
